- 3. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Nrs. 4,84,25,500.00.
 - Minimum Work experience of similar size and nature: 1(one) number of building project with minimum value of Nrs. 5,20,00,000.00.

- 7. Intrested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp. to office of Indrawati rural Municipality on or before 12:00 hours on 2076/03/20 (05/07/2019). Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours on 2076/03/20 (05/07/2019) at the office of Indrawati Rural Municipality, Nawalpur, Sindhupalchok. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format ammounting to minimum of NRs. 18,25,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
